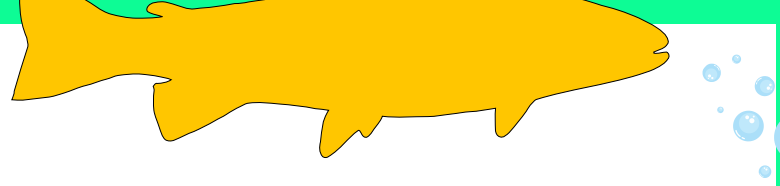

# Introduction



Welcome to Pathways of the High Seas, a summer camp experience designed for youth ages 14–16. This guide outlines important policies and expectations to ensure a safe, respectful, and engaging environment for all campers, staff, and guests. Please review this document carefully with your camper prior to the start of camp.

Campers will discover diverse organisms and their equally diverse habitats at Georgia Aquarium, from local ecosystems to the distant arctic and the tiny brine shrimp to the massive whale shark, there is always something to get excited about!


We create and foster a fun, safe learning experience. All our educators are certified in First Aid, CPR/AED, and Epi-Pen administration. Georgia Aquarium is a KultureCity Sensory Inclusive certified. To provide the best experience for your camper, we highly encourage you to share any medical or behavioral needs. This information is never shared with other campers or their parents. Additionally, for the safety of all campers and staff, parents or guardians are not permitted to follow or attend camp activities or campers during camp hours. **Camp runs Monday through Thursday 9:00am to 3:30pm.**



Our camps are divided into age specific groups: 5 to 7 years old, 8 to 10 years old, and 14 to 16 years old. These camps are tailored to engage each age specific range, so it is important campers are registered for their age-appropriate camp!





Campers are highly encouraged to ask questions, participate in activities, and share their experiences with parents/ guardians. With enough inspiration, we can work together to create a sea of change in our local waterways down to the ocean creating lasting impacts for the wondrous life that inhabits our world.

# Registration Policies

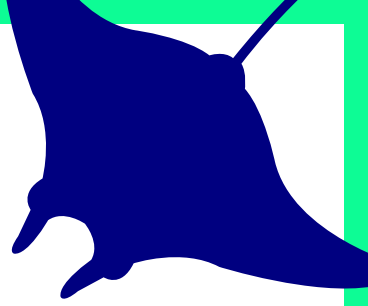
## General Policies



- Reservations are required.
- Walk-up purchases are not available.
- Full payment is due upon reservation.
- Changes to reservations made 2 weeks or less prior to the scheduled event date are subject to Georgia Aquarium Education managerial approval.
- Camp H2O is exclusively for campers ages 5 to 10 and 14-16 years old. In order to participate in Camp H2O, campers must be the correct age of the camp they are registered to by January 1, 2026.
- We may ask for verification of your child's age prior to the first day of camp.
- Campers must be registered to an age specific camp. Georgia Aquarium retains the right to cancel or alter reservations for campers registered inaccurately into an age specific camp.
- If you have a request for your camper to be in the same group as another camper in their age range, you must let us know by the Thursday before the camp you are registered for. Once camp begins, we are unable to change camper groups.
- Camper forms and information must be filled out prior to the first day of camp for each week your camper is attending.



# Refund and Cancellation Policies



- Cancellations may be requested at any time prior to or during camp programming.
- Cancellations do not guarantee a refund and are subject to refund policies.
- Refunds will NOT be issued for cancellation requests received within 2 weeks of the scheduled camp date.
- Refunds will not be issued for no-shows.
- Partial attendance of camp will NOT result in refunds for individual days missed of summer camp week.
- Refunds will not be issued based on dissatisfaction of camp program.
- Campers sent home early at Education staff discretion will not receive a partial or full refund for the day.

## Date Change Policies

- Date changes that occur within 2 weeks of scheduled camp date will incur a 25% fee per reservation.
- Date changes are subject to availability and may require Georgia Aquarium Education managerial approval.



# Cell Phone Policy

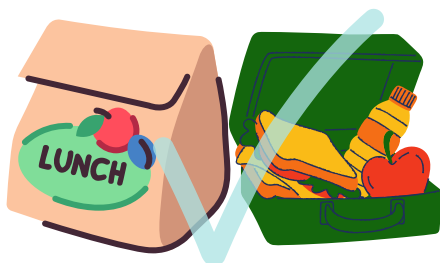
- To promote engagement, safety, and positive social interaction, cell phone use is limited during camp hours.
- Cell phones must remain put away during instructional time.
- No video calls, live streaming, or recording of any kind is permitted.
- Excessive cell phone use is not allowed.
- Phones may only be used in the event of an emergency and only with instructor permission.

Failure to comply with the cell phone policy may result in confiscation of the device for the remainder of the day.

## General Information

### Lunch and Snacks

- **Please make sure you pack your child's lunch each day.** We recommend packing lunch in thermal bags; campers will not have access to a microwave or refrigerator.
- Camp H2O **does not** provide lunch for campers, nor are campers able to purchase lunch at Georgia Aquarium's cafeteria.
- Light morning and afternoon snacks are provided by Georgia Aquarium.
- Snacks will not contain nuts and aim to avoid common allergens.
- If your child has severe food allergies or dietary restrictions, we highly encourage you to pack them a snack in addition to their lunch.
- **Snacks and lunches containing any nuts are not permitted.**



# General Information

## Dress Code:

---

Campers are expected to dress in a manner that is safe, appropriate, and respectful of the learning environment.

The following dress code applies at all times during camp:

- Closed-toe shoes are required.
- Clothing must be free of rips, tears, or holes.
- Shirts must fully cover the torso; no exposed midriff or stomach.
- Clothing should not contain inappropriate language, images, or symbols.



## Notes

Campers who arrive out of dress code may be asked to change or may be restricted from participating in certain activities.

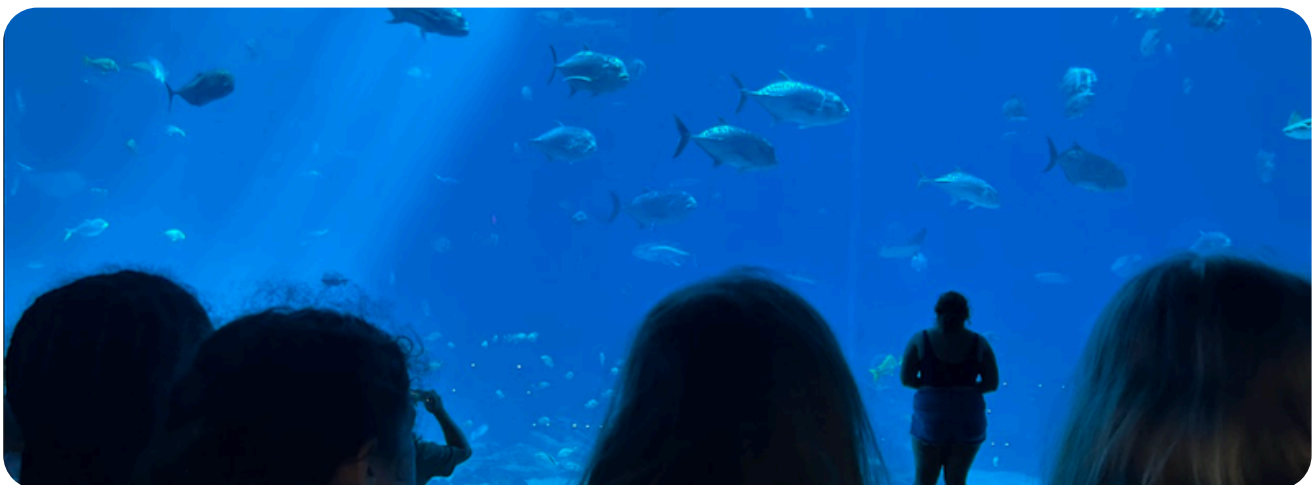


## Personal Items

- Campers are welcome to bring personal items including fidget items; however, the following are not permitted at Camp H2O:
  - Toys
  - Money
  - Loose jewelry
  - Card games or collectables
  - Gum
  - Weapons or other inappropriate items
  - Tablets or game systems
- These items will be confiscated and returned to a parent at the end of the day.
- While we realize that some campers may have cell phones in order to keep in contact with parents, we recommend talking with your child about limiting their cell phone use during camp hours.
- Georgia Aquarium is not responsible for any lost, stolen, or damaged items.

- The confirmation email you receive when you register for camp is your receipt of payment.

# Dropoff Procedures

## Arrival- 8:30 AM to 9:00 AM

Camp dismissal begins at 3:30pm and concludes promptly at 4:00pm. Camp dismissal may begin prior to 3:30pm if all camps are present and authorized picks up are present.

## Vehicle Drop-off/Arrival Procedures and Notes


- Educators will come to your car and guide your child to the entrance. For your child's safety we are required to check in each camper before the driver leaves the location. PLEASE DO NOT LEAVE YOUR CAR.

## Walk up Drop-offs/Arrivals Procedures and Notes

- Walk-up arrivals are handled by an Education department staff member outside the Education Entrance doors. This includes volunteers or staff members dropping off campers. Please do not leave campers until they have been checked-in and confirmed with an Education department staff member.

## Late Drop-offs/Arrivals

- If campers need to be dropped off after 9:00 am, contact Georgia Aquarium Education staff by phone or email prior to camp day.
- If a camper is running late, call Georgia Aquarium education at 404-581-4080 to notify staff. If there is no response, please leave a voicemail.
- Late arrivals will drop off in the same location. Upon arrival, please call 404-581-4080 to notify education staff of your arrival. Remain in the car with the camper until a member of the Education staff can escort campers.

- Security may come over to the car to speak with you, let them know you are a late drop off for Camp H2O, and they will be able to assist with a safe arrival.

## Pick-Up Procedures


### Dismissal – 3:30 PM to 4:00 PM

Camp dismissal begins at 3:30pm and concludes promptly at 4:00pm. Camp dismissal may begin prior to 3:30pm if all camps are present and authorized picks up are present.

### Vehicle Pickup Procedures and Notes

- **Step One:** A staff member will confirm identity of pickup person and Camper ID# to ensure camper's safety prior to permitting campers to leave the building.
  - If the person picking up is not listed as an authorized pick-up and Education staff was not notified by email, there may be a delay in pick-up as Education staff will have to confirm authorization for pick-up.
  - We are required to check out each camper before they leave with the authorized adult, this may take several minutes.
- **Step Two:** An Education staff member will accompany your child to your vehicle and discuss any positive or negative events that occurred as necessary.
  - Please pull out of the line if you need to adjust your child's car seat, seat belt, etc.

### Walk- Up Pickup Procedures and Notes

- Walk-up dismissals are handled by an Education staff member on the curb of Baker Street in front of the Education Entrance (the same place that walkers are dropped off in the morning).

# Pick-Up Procedures

## Early and Late Pick-Up Procedures

### Early:

- If camper(s) will need to be picked up before 3:30 pm, contact Georgia Aquarium Education staff by email by 10 AM THAT DAY.
- The early dismissal location is on Baker Street, where the arrival process takes place. Early dismissals can be facilitated by Education staff until 2:00 pm. If you need to pick-up after 2:00 pm, you will have to wait until regular dismissal at 3:30 pm.
- If you fail to notify Education staff of an early pick-up prior to arrival, there will be a delay in getting the camper connected. Wait times can be 30 minutes or more, so notifying staff as soon as possible is highly encouraged.

### Late:

- After 4:00 pm, Education management will reach out to the camper guardian regarding late pick-up. All pick-up after 4:00 pm will incur late fees.
- Campers picked up after 4:00 pm will be charged \$10.00 per child with an additional \$5.00 per minute/per child after 4:00 pm.



# Pickup and Dropoff

## Campers Driving Themselves to Camp



Campers who are legally permitted to drive themselves to camp must follow all established safety and conduct expectations. By choosing to drive, campers agree to comply with the following requirements:

- Campers must possess a valid driver's license and comply with all state and local traffic laws.
- Vehicles must be parked only in designated parking areas.
- Campers may not transport other campers unless written authorization has been provided by all parents/guardians involved.
- Reckless driving, speeding, or unsafe behavior may result in loss of driving privileges for the remainder of the camp session.
- Campers driving themselves must arrive and depart only during approved camp hours.

Failure to comply with these expectations may result in disciplinary action and/or revocation of self-driving privileges.

### **Student Driver Drop-Off and Pick-Up**

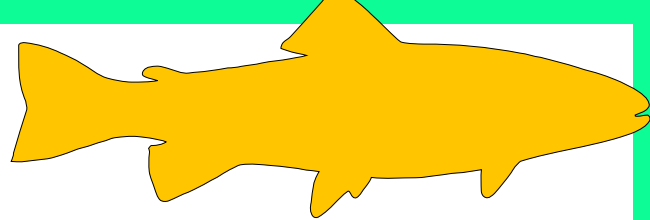
- Student drivers authorized to drop off and pick-up at Camp H2O must follow all established camp drop-off and pick-up policies at all times.
- Once student drivers have checked out, an email will be sent to the parent or guardian to confirm that the student has been released from camp.

### **Designated Driver Check-In and Check-Out**

Campers who are not driving themselves must be checked in and out by a designated driver. All policies and procedures listed within this document must be followed.



# Pickup and Dropoff



## General Details

### Directions and Parking

- The Arrival and Dismissal location is on Baker Street near the intersection of Baker and Luckie Street, across from Centennial Olympic Park. Look for the Camp H2O signs on the curb. A member of the Georgia Aquarium Education team will assist you at the curb.
- If you are using a GPS, use the following address for a more direct route to Georgia Aquarium parking: 225 Baker Street, NW, Atlanta, GA 30313.
- NOTE: This address may take you to our parking decks and not the drop off/pick-up zone.
- Please ONLY use the designated area for camp arrival and dismissal. The Atlanta Police Department has extended Camp H2O the courtesy of using this lane for drop-off and pickup; however, they retain ultimate jurisdiction over traffic and parking.

### Code of Conduct in the Parking Garage

All campers, parents/guardians, and visitors are expected to follow the facility's parking code of conduct while onsite.

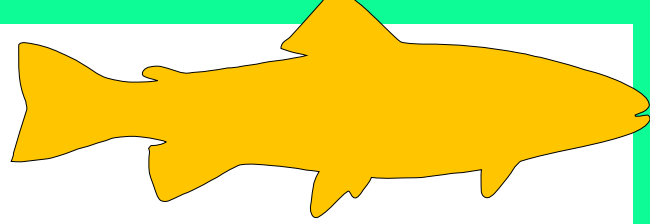
- Drive slowly and cautiously at all times.
- Follow posted signage and directions from security personnel.
- No loitering, horseplay, or disruptive behavior in the parking deck.
- Keep noise levels respectful and appropriate.
- Respect property, vehicles, and individuals at all times.
- Smoking and vaping are prohibited in the parking garage and anywhere on Georgia Aquarium property.

Violation of parking garage conduct expectations may result in loss of parking privileges or further disciplinary action.



# Pickup and Dropoff

## General Details



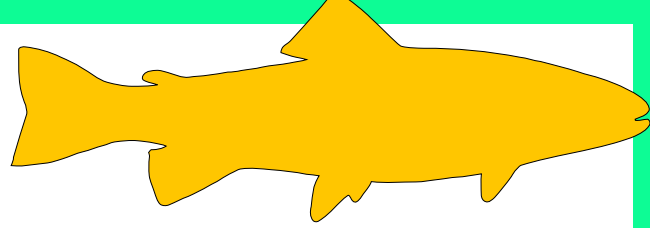
### Parking Validation

- Parking will be validated for the duration of this camp only for self-driving campers who are registered for Pathways of the High Seas and have been approved to drive themselves.
- Campers who drive themselves must check in and out **in person** with Security and an Operations Specialist or a member of Education Leadership **before entering camp or proceeding to the parking deck.**
- Failure to properly check out may result in revoked parking privileges.

### Safety Procedures

- Campers are assigned a Camper ID number for pick-up and drop off. This number is the last four of your order ID number. This number must be displayed at pick-up and drop off.
  - If driving, please have this number on the car dashboard.
  - If walking, please have this number in hand and visible.
  - This number can be located on your ticket receipt.
- Each Monday during camp drop off, the Georgia Aquarium Education team will provide a copy of the Camper ID number if you do not already have it.
  - If more than one person will be picking up or dropping off camper(s) throughout the week, the Camper ID number is required. A copy of the ID number or handwritten version will be accepted.
- For your camper's safety we will not release them unless the appropriate Camper ID number is provided by an authorized person at dismissal.

## General Details Cont.



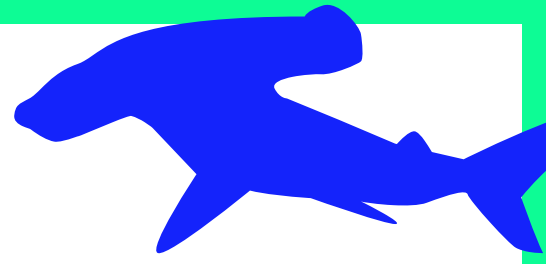
### Safety Procedures Cont.

- Authorized pick-up are provided during registration. If your child will be picked up by someone not provided during the initial registration, you will need to notify Georgia Aquarium staff prior to pick-up and ensure the person has the Camper ID number.
- Each camper can have a MAXIMUM of 5 authorized pick-up, which includes guardians.
- You may notify staff of additional authorized pick-up not originally provided during registration by emailing [education@georgiaaquarium.org](mailto:education@georgiaaquarium.org).
  - If you fail to notify staff prior to pick-up, there may be a delay as Education staff will need to contact parents/ guardians to confirm

## Emergency Pickup

- Parents will be notified by email prior to pick-up/ drop off if there are any changes needed to occur to standard procedure.
- Campers and parents must remain in their cars until Education personnel can get camper(s) checked in or out. Once out of the car, camper(s) will be escorted into or out of the building by an Education staff member.
- If a camper needs to be sent home early at the discretion of Georgia Aquarium Education staff, they will not be eligible for a partial or full refund. Education staff will notify guardians of the best location for early pick-up.
- In the event of an emergency and your camper needs to be dismissed immediately, we will call you or you may call 404-581-4242 to reach the Security department.
- The emergency dismissal location is on Baker Street where the arrival process takes place.

# Required Forms



## General Information

- Please have the following forms completed, signed and returned prior to the first day of camp:
  - Parent/Guardian Permission form
  - Camper Behavior Contract form
  - Authorization to Dispense External Preparations form
  - Photo Release
  - Vehicle Registration Form (required for any camper authorized to drive themselves to camp)
  - Copy of valid drivers license
- All campers MUST have a signed and completed waiver on file before they will be permitted to attend camp.
- Digital submissions are strongly encouraged and can be completed at <https://form.georgiaaquarium.org/camp-waiver>.
- Campers may turn in a paper copy the Monday of camp; campers without a waiver on file **will not be permitted to attend camp** until a completed and signed waiver is received.



# Parent/Guardian Permission Form

I hereby give permission to my child or dependent to participate in all activities involved in the Camp H2O at Georgia Aquarium Program, expressly and specifically acknowledging that those activities may include, without limitation, water-related activities at the Georgia Aquarium and travel to and from the Georgia Aquarium.

I understand and acknowledge that, in participating in such activities, my child or dependent, though always in the presence of an adult, may not be constantly monitored. I further understand and acknowledge the risk of physical injury or damage to property as a result of my child's or dependent's participation in the activities.

I hereby give permission for my child to visit Centennial Olympic Park and Pemberton Place, which are located adjacent to Georgia Aquarium. My child will be escorted to and from all locations by Georgia Aquarium Staff. While outdoors and at other locations, my child will be properly supervised by the Education Department staff. I understand and acknowledge the risk of physical injury or damage to property as a result of my child's or dependent's involvement at Centennial Olympic Park and Pemberton Place.

I hereby authorize the Georgia Aquarium, or its designee(s), to take my child or dependent to a hospital or other medical facility in case of any emergency and to consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care of my child or dependent deemed advisable by a licensed physician and provided by that physician or under that physician's supervision, regardless of where that treatment is provided.

In consideration of my child or dependent being allowed to participate in the activities at the Georgia Aquarium described above, I hereby release and discharge the Georgia Aquarium and its directors, officers, employees, agents, volunteers, and other representatives, from any and all liability, claims, losses, and demands whatsoever that my child or dependent or I may have for injuries or property damage arising or resulting from my child's or dependent's participation in the activities described above, whether or not resulting from negligence, all of which claims I hereby waive both for myself and for my child or dependent.

I acknowledge and agree that attendance and involvement in the activities described above are voluntary, that my child or dependent is participating at his or her own risk, and that I have read the terms and conditions of this waiver and release.

I understand and agree that this waiver and release shall be fully binding on me, my child or dependent, my estate, my child's or dependent's estate, my heirs, and my child's or dependent's heirs, and that neither I nor my child nor my dependent nor anyone claiming through me or my child or my dependent shall have any legal right to assert a claim against the Georgia Aquarium or its directors, officers, employees, agents, volunteers, or other representatives, relating to my child's or dependent's participation in such activities.

# Camper Behavior Contract

Camp H2O is going to be an exciting and hands-on experience that will leave your camper with memories that last a lifetime! In order to ensure that each camper has a safe and positive experience, we want all of our camp families to understand that the physical and emotional safety of our campers and animals is paramount. To that end, please review this Camper Behavior Contract with your child(ren) or dependent(s). If a camper is in violation of the behavior contract, the camper may, at the discretion of staff, face consequences up to and including dismissal from camp with no partial or full refund. Bullying of any kind is inexcusable and grounds for immediate dismissal from camp. Georgia Aquarium will pursue the following in the event a camper violates the behavior contract:

**First Occurrence:** The first occurrence will result in a call home or conversation during pick-up with Georgia Aquarium staff. In the case where kicking, biting, or other severe behavior occurs, the child may automatically be given a one-day suspension from the program with no refund for that day.

**Second Occurrence:** The second occurrence of severe behavior will result in a conversation with Georgia Aquarium staff and parents, potentially resulting in expulsion from camp without a refund. A member of the management staff of Education will make a final determination for expulsion.

Campers and Parents: Must return the signed contract prior to your first day of camp.

1. Stay with your assigned camp instructor and always listen to instructions.

- I will stay with my assigned camp instructor(s) throughout the entire camp experience.

- I understand that for my safety, wandering throughout the aquarium is not permitted.

- I understand running is not permitted and will only do so with permission from camp instructor(s).

- I will always follow my camp instructor's directions and ask questions if needed.

- I understand that my questions are valued and encouraged – if I don't ask, I'll never know!

2. Be on your best behavior.

- I will be respectful of my fellow campers, all program staff, and the animals with my words and actions.

- I will listen when others are speaking and speak to others in a respectful manner and tone.

This includes using my "inside" voice inside the Aquarium.

- I will not threaten or cause physical harm to others, including but not limited to possessing sharp or otherwise dangerous instruments.

- I will respect the personal space of others and keep my body to myself.

- I understand that disrespectful behavior includes but is not limited to hitting, punching, kicking, biting, spitting, swearing, teasing, lying and not listening to my camp instructor.

- I understand that bullying – both physical and emotional – is inexcusable and is grounds for immediate dismissal from camp.

- I will be respectful of the aquarium grounds, buildings, and animal habitats.

- I will not litter, vandalize, steal, or destroy items that do not belong to me.

- I agree to follow all Camp H2O rules including those that are not listed on this behavior agreement.



# Camper Behavior Contract

3. Respect the animals and their homes.

- I understand that tapping on the windows or yelling at the animals can be very disturbing and harmful to their health, and will refrain from doing so.

- I will not feed the animals or put items into an exhibit.

- I will wait until I am instructed as to when and how I may touch the animals.

4. Electronic use should be limited during the camp day.

- I understand that I am not to play on my phone, tablets, electronic toys, or other devices during the camp day.

- I will put away my cellphone or electronic device when requested by camp instructors or Georgia Aquarium personnel.

- I understand that I will not take pictures of other campers without their consent.

- I understand that I am not permitted to display inappropriate images, videos, or sounds on my phone or electronic device(s).

4. Have Fun!

- I agree to HAVE FUN and help my fellow campers have fun!

Agreement Statement: I have read the Camper Behavior Contract with my child and accept responsibility for his/her behavior during enrollment in camp. I understand that my child may be removed from an activity if this contract is violated. When a parent or guardian initially registers a child with an exempt program, the parent or guardian shall sign a form indicating the parent or guardian has been advised and understands that the program is not licensed and is not required to be licensed by the state.

# Authorization to Dispense External Preparations

Except for first aid, Georgia Aquarium personnel shall not hand out prescription or non-prescription medication (including sunscreen) to a child without specific written authorization from the child's physician or parent. All medications shall be stored in accordance with the prescription or label instructions and kept in places that are inaccessible to children. Each dose of medication given to a child is required to be documented showing the child's name, name of medication, date and time given, and the name of the person giving the medication. It is required that on-site First Aid be notified for any serious or life-threatening situations.
